The proceedings will be conducted in English and will take place in Zurich.

If any provision of the TOS is found to be invalid, the parties nevertheless agree that the parties' intentions as reflected in the provision shall be given effect to the fullest extent practicable, and the other provisions of the TOS remain in full force and effect. You may not assign or transfer any of your rights or obligations, or subcontract the performance of any of your obligations, under these TOS.
